The ISO/TS 22002-4 is a document developed specifically for food packaging manufacturers. It identifies the requirements for prerequisite programs that apply directly to the industry. The certification is recognized by GFSI, which means that your certification will be well recognized and accepted by many retailers and food manufacturers worldwide.

FSSC 22000 is based on ISO 22000 but is not sufficient to be recognized by the GFSI on its own. Pre-requisite Programmes (PRP): based on ISO/TS 22002-1 which include requirements for construction and layout of building, maintenance services, product information, personnel hygiene, food fraud and defence systems etc.
